FAMILY PLANNING SERVICES IN CURATIVE INSTITUTIONS

Family planning services have made a significant contribution towards the impressive health indicators of Sri Lanka. Whilst further improvement of the health status requires strengthening of family planning services, any setback of service provision will have an adverse impact on even the existing achievements.

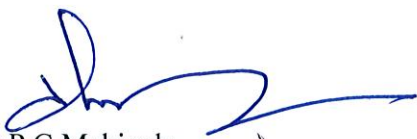
However, it has been highlighted at review meetings that there is a decline in family planning services due to unavailability of regular family planning clinics in curative institutions.

In order to revamp & strengthen the family planning programme, all curative institutions are required to abide by following instructions:

Specialist hospitals - According to the existing norms, all specialist hospitals upto the level of Base Hospitals should have a dedicated Family Planning Clinic functioning for six days of the week.

Non-specialist hospitals – Immediate action should be taken by Heads of non-specialist hospitals, upto the level of Primary Medical Care Units, to provide family planning services in their respective institutions, six days of the week.

Provincial Directors of Health Services, Regional Directors of Health Services, and Heads of Institutions are requested to ensure that the above instructions are carried out in their respective areas/institutions.
